

## UNITED FLOORS/SHAW HOMEPOD MINI GIVEAWAY

### OFFICIAL CONTEST RULES AND REGULATIONS

#### 1. Eligibility

A purchase of any Shaw Floors product at any United Floors location from October 12<sup>th</sup>- 30<sup>th</sup> would be required to be entered into the draw. The United Floors/Shaw HomePod Mini Giveaway Contest (the Contest) is open to legal residents of Canada (excluding Quebec) who are age of majority in their province or territory at time of entry. Employees of United Floors, its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, (collectively the "Employees"), and immediate family members and/or those living in the same household of Employees are not eligible to participate in the Contest. The Contest is subject to all applicable federal, state, and local laws and regulations. Void where prohibited.

#### 2. Agreement to Rules

Entries will be accepted at the store starting on all invoices dated between October 12<sup>th</sup> and October 30<sup>th</sup>, 2021. All entries must be received by October 30<sup>th</sup>, 2021.

#### 4. How to Enter

To enter the Contest, purchase any Shaw Floors product at any United Floors location from October 12<sup>th</sup>-30<sup>th</sup>, 2021. An entry will be in a form of a ballot provided by the store after an eligible purchase is completed. The entry must fulfill all Contest requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of United Floors. Optional verbiage to include: You may enter only once. You must provide the information requested. You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules. If You use fraudulent methods or otherwise attempt to circumvent the rules, your submission may be removed from eligibility at the sole discretion of United Floors.

United Floors reserves the right, in its sole discretion, to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the Contest or violates these Terms & Conditions. United Floors has the right, in its sole discretion, to maintain the integrity of the Contest, to void votes for any reason, including, but not limited to: multiple entries from the same user from different IP addresses; multiple entries from the same computer in excess of that allowed by Contest rules; or the use of bots, macros, scripts, or other technical means for entering.
